Re: Summary of Key Points from the Barnsley Area Prescribing Committee Meeting on 8th November 2023.

The main outcomes of the meeting were: -

Prescribing Guidelines

The following prescribing guidelines were approved by the Committee:

Un-investigated Dyspepsia Pathway [NEW]

This pathway has been adapted from the British Society of Gastroenterology guidelines on the management of functional dyspepsia September 2022 and the NICE Dyspepsia Guidelines CG 184. It includes causes of dyspepsia, investigations and management of functional dyspepsia in primary care.

Amber G / Shared Care Guidelines

The following amber-G / shared care guidelines were approved by the Committee:

Goserelin 3.6mg implant (Zoladex®) Amber-G guideline for adjuvant treatment of breast cancer in premenopausal and perimenopausal women [UPDATED]

This guideline has undergone a routine update in line with the current BNF and SPC. The following changes have been made:

- The specialist should specify the length of treatment with Zoladex® 3.6mg implant.
- Since androgen deprivation treatment may prolong the QT interval, the specialist should consider carrying out a baseline ECG prior to the initiation of Zoladex®. The specialist should also consider repeating the ECG post initiation of Zoladex® (added to monitoring section).
- The specialist should assess the risk of osteoporosis (goserelin may cause reduction in bone mineral density). The specialist will request the baseline DEXA scan where required. Once the patient is discharged, the primary care clinician should request any further DEXA scans if recommended after the baseline scan (added to monitoring section).
- Patients with known depression and patients with hypertension should be monitored carefully. The
 following has been added to the monitoring section: In the case of patients with known depression,
 the patient should be counselled by the initiating specialist, and this should be documented in the
 patient's notes. Blood pressure should be measured before initiation of Zoladex® and if the patient

is found to have hypertension, the primary care clinician should be advised in writing so that the patient can be managed appropriately.

Shared Care Protocol for the Use of Efmody® in Patients with Adrenal Insufficiency (CAH) [NEW]

Issues relating to primary care:

Valproate: dispense full packs of valproate-containing medicines

Unless there are exceptional circumstances, valproate-containing medicines must always be dispensed in the manufacturer's original full pack.

Following a consultation, the Government has amended the Human Medicines Regulations 2012 (HMRs) to require manufacturer's original full pack dispensing of valproate-containing medicines. The MHRA published guidance for dispensing of valproate-containing medicines: <u>Full pack dispensing of valproate-containing medicines - GOV.UK (www.gov.uk)</u>. The change came into force in England, Scotland and Wales on 11 October 2023. Further information can be found in the <u>October Drug Safety Update</u>.
